





Instructions

- 1. Begin by reading through A Call to Volunteer. If you have concerns or questions, please contact Hope and Grace International (HGI) to discuss them at 503-789-0974 or joni@hopeandgraceinternational.com.
- 2. Fill out the Confidential Volunteer Application and email it to joni@hopeandgraceinternational.com.
- 3. Email a reference form to your pastor or ministry leader. If for any reason you do not know one well, contact your church office and request an appointment with one of the pastors, explaining the purpose. At the meeting, he or she should ask you questions about your relationship with the Lord and about your lifestyle that will enable him or her to fill out the reference. In addition, you will have the opportunity to get to know one another.
- 4. Email a reference form to three other people, not related to you but who know you well, preferably a pastor, a co-worker or business associate, and a friend. Encourage your references to return the forms as soon as possible.
- 5. When HGI receives the application and references, they will call you to arrange an individual interview. At the interview, you will fill out a Consent to Perform a Criminal Background Check form. By the end of the interview, you and the HGI representative yourself will usually be in agreement about your volunteer role.
- 6. Any training times and locations will be discussed at your interview.
- 7. While you're waiting for the interview, please keep a running list of your questions about volunteering in the *SAFECHURCH Project* through your church and bring them to discuss during the interview.
